



## International Sponsoring Eurasia and Israel

Policies and Procedures for Neways Markets as of Jan 2011  
December 2010

Neways is pleased to offer international sponsoring and earning opportunities to all Neways Executive Distributors that are interested in sponsoring Distributors within any Neways Eurasia Territories (Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Ukraine, Uzbekistan, Turkmenistan, Latvia, Estonia, and Lithuania) and Israel.

These Policies and Procedures outline the rules of conduct regarding the development of Distributor downlines in any Neways Eurasia Territories and Israel.

1. All Neways Distributors interested in sponsoring Distributors in any Neways Eurasia Territory and Israel must first submit a completed International Sponsoring Application to Eurasia and Israel to the Global Sponsoring department of Neways.

2. Neways Distributors must achieve the rank of Executive prior to submitting an International Sponsoring application to Eurasia and Israel. International Sponsoring applications submitted to Neways prior to a Distributor achieving the rank of Executive will not be approved.
3. Processing of International Sponsoring applications may take up to 7 business days. Once your International Sponsoring application is approved, you will receive a unique Neways Eurasia ID# that should be used for all communication with the Neways Eurasia offices, including the Sponsor ID# to be listed on any Distributor Applications for new Distributors that you sponsor in any Neways Eurasia Territory or Israel.
4. As a registered International Sponsor to Neways Eurasia and Israel, you are only authorized to sponsor new Eurasian Distributors in approved Eurasian Territories and Israel. Approved Eurasian Territories include: Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Ukraine, Uzbekistan, Turkmenistan, Latvia, Estonia and Lithuania.
5. Neways Distributors must maintain Executive Leadership qualifications in their home market to be eligible for any international commissions. Monthly qualifications for international commissions are based on the Neways Distributor's previous month home market qualifications. For example if you qualified as a Master Executive in June 2010, you would be paid as a Master Executive on international Neways Eurasia and Israel volumes for the July 2010 commission period.
6. Calculation and payment of all international Neways Eurasia and Israel commissions are based on the Neways Eurasia compensation plan. All international commissions are subject to local

market maintenance fees. All International Neways Eurasia commissions will be paid in USD from the office of Neways Eurasia.

7. As an International Sponsor to Eurasia and Israel, you are only eligible for international Eurasia and Israel commissions on international Eurasia and Israel downlines you personally recruit.
8. Neways International Sponsors to Neways Eurasia and Israel cannot sponsor other Neways Distributors in any Neways Eurasia market or Israel.
9. Neways Distributors may only purchase Neways products from Neways. All products purchased for delivery to any Neways Eurasia market or Israel must be placed directly with the Neways Eurasia office. No Neways office will ship products directly or indirectly to any Neways Eurasia or Israel Distributor or Neways Eurasia Territory or Israel. Likewise, no Neways Distributor can directly or indirectly ship Neways products to any Neways Eurasia Territory or Israel.
10. Neways Distributors cannot register as a separate Neways Eurasia and Israel Distributor by completing a Neways Eurasia and Israel Distributor application and agreement form. Potential Distributors in any Neways market, must register as a Neways Distributor and complete the International Sponsoring to Eurasia and Israel application to sponsor any Distributors in any Neways Eurasia Territories or Israel.
11. Any duplicate International Distributorships (secondary distributorship operating as a separate Distributorship in any Neways Eurasia Territory or Israel) identified by Neways or Neways Eurasia will be removed from the Neways Eurasia systems and ineligible for any future international commissions. A one-time grace period is offered to any existing duplicate accounts that are registered as an International Sponsor prior to January 31, 2011.
12. Operating as an International Sponsor means you will be running an international business. We recommend that you contact your tax advisor concerning any international income you receive. You may experience increased business expenses to maintain contacts with your international downlines. International markets have different taxation, regulations, and requirements for doing business (including work visas, permits, etc.). As an International Sponsor, you are responsible for researching these and other international business practices.
13. These International Sponsoring policies and procedures may change at any time without notice. Please refer to the Neways website:
