INTERNATIONAL SPONSORING INFORMATION

As an international distributor, you will be assigned a new regional ID# which will include a 3 letter prefix that identifies the location of your distributorship (Australia distributors would receive an AUSXXX ID number) that allows you to conduct business in Korea. This new regional ID number will be used to identify yourself with the Neways Korea office.

If you have not developed a downline in Korea, Japan, Taiwan or Hong Kong, you will be assigned your new ID# at the time of sponsoring your first downline distributor in Korea. To register your first downline distributor in Korea, please email or post mail the completed 2 page Distributor Application and Agreement (front and back) to Neways Korea. You must have an assigned regional ID# prior to using the online registration system at www.korea.neways.com.

Your new regional ID# will allow you to conduct your Neways business in Korea, Japan, Taiwan and Hong Kong, as these countries operate as a Neways seamless region.

HOW TO SPONSOR

During “Pre-Launch” activities, Neways Korea will only accept distributor applications that are submitted electronically at www.korea.neways.com, emailed to info@newaysonline.kr or mailed to the Neways Korea mailing address.

Information required for distributor application:

- Sponsor ID number
- Name, address, phone number, birthdate, gender
- Government ID number

Distributor application and agreement forms are processed immediately when submitted electronically, or within 3 business days for applications received by mail. New Distributors are eligible to sponsor immediately upon the completion of Neways processing the application and agreement form.

You can submit the application and agreement in the following ways:

- Electronically at www.korea.neways.com
- Email the completed 2 page Distributor Application and Agreement (front and back) to info@newaysonline.kr
- Post mail the completed 2 page Distributor Application and Agreement (front and back) to the Neways Korea mailing address

Tip:

If you do not have a regional ID#, you will need to submit your first downline distributor application and agreement form by email or postal mail. Once you have been assigned your regional ID#, your new distributors can utilize the online registration system.
