

How-To Internationally Sponsor in the Taiwan Market

1. Distributor application and agreement forms are available by contacting the Neways Taiwan office at +886-2-2364-0878. Neways Taiwan office hours are Monday through Friday 12 p.m. to 8 p.m. and Saturday 1 p.m. to 5 p.m. (Taiwan Standard Time).
2. Distributor application and agreement forms must be accompanied with a minimum product order of at least 50 PV.
3. Submit the completed distributor application and agreement form and order form to Neways in person or mail to:

Office hours are Monday through Friday 12 p.m. to 8 p.m. and Saturday 1 p.m. to 5 p.m. (Taiwan Standard Time)
4. Distributor application and agreement forms are processed immediately when delivered in person to the Neways Taiwan office or within 1 business day for applications received by mail.
5. New distributors are eligible to sponsor new distributors immediately upon the completion of Neways processing the application and agreement form.
6. New distributors receive a free information kit (sent with order if not placed in person) upon the acceptance of their distributor application and agreement form and 50 PV order that includes:
 - Getting Started booklet
 - Order form
 - Distributor Application form
 - Compensation Plan brochure
7. New distributors receive a password for access to the Neways Taiwan Business center that includes information regarding building a Neways business in Taiwan, distributor policies and procedures, order processing, product information and other Neways news and information. The password is located on the copy of the distributor's completed application and agreement form that is received from Neways once the application has been processed.
8. Neways Taiwan compensation plan can be viewed at <http://images.neways.com/corporate/TWNcompbrochure.pdf>.
 - Distributors must maintain a minimum 100 PV each month to qualify for both Multiplex and Affinity profit center commissions.
 - Executive Leadership monthly qualification is 100 PV, 1,000 PGV (personal group volume), and 400 APGV (affinity personal group volume)
 - Additional qualification levels and values are specified in the complete Taiwan compensation plan brochure that can be viewed by selected the above link.
9. Any international distributors that have already sponsored a new distributor in Taiwan and have received a Taiwan market ID#, are eligible to utilize the Neways Taiwan on-line distributor registration system. The on-line registration system is

available for your new distributors to sign up at www.neways.com/tw. Your new distributors need to select the Join Now tab and follow the simple instructions to process their new distributor application and agreement form. Of course, you can always continue to submit new distributor application and agreement forms to Neways by fax or mail to the above address.

How-To Place a Product Order in Taiwan

1. Distributors can place product orders four convenient ways:
 - Online at www.newaysonline.com/tw by selecting the PRODUCTS link and selecting the products and quantity needed. Select the checkout button to complete the transaction and follow the simple instructions to complete the transaction. You will need to provide your Taiwan distributor ID# and password (located on your welcome letter).
 - Showroom in Taipei. Office hours are Monday through Friday 12 p.m. to 8 p.m. and Saturday 1 p.m. to 5 p.m. (Taiwan Time zone).
 - Fax purchase order forms to +886-2-2364-3835. Purchase order forms can be printed from the Neways distributor business center.

2. Accepted payment methods include: Visa, Mastercard, U-Card, JCB, cash (showroom orders only), bank transfer (fax, mail and showroom orders only).

Distributor Commission Payment Options

Commission payments are paid on the 25th of the month following the close of the commission period.

Commission amounts greater than 850.00 NTD are paid by electronic direct deposit to a Taiwan bank or post office account. Distributors must complete the direct payment information on the distributor application and provide a copy of their bank book information. Additionally the information can be submitted online by logging on the business center website and sending a copy of the bank book information to Neways. All international commissions are paid by check (minimum check amount is 50.00 USD).
